



12th IRGCE 2026 Conference Registration Terms & Conditions

These Terms & Conditions apply to all delegates registering for the 12th International Rubber Glove Conference & Exhibition (12th IRGCE 2026) organised by the Malaysian Rubber Glove Manufacturers Association (MARGMA). By submitting a registration, participants agree to be bound by the following terms.

1. Registration & Eligibility

- All registrations are subject to acceptance by the Organiser.
- Registration is deemed confirmed only upon receipt of full payment.
- Registration is non-transferable without written notification to MARGMA

2. Registration Fees

- Fees include access to conference sessions, conference materials, and refreshments as outlined in the official programme.
- Fees exclude accommodation, transportation, visa fees, insurance, and personal expenses.
- MARGMA reserves the right to cancel the registration if no payment is received prior to or on the date of the event.
- Full fee is charged regardless of the length of time the participant attends the event and cannot be pro-rated.

3. Sales & Service Tax (SST)

- Conference fees are subject to the prevailing 8% Sales & Services Tax (SST), where applicable.
- Any change in tax rates imposed by the Government of Malaysia shall be borne by the participant.

4. Payment Terms

- Full payment must be received within the registration schedule and payment deadline stated on the invoice.
- Accepted payment methods include bank transfer, credit card and other methods as specified by MARGMA.
- All bank charges, foreign exchange costs, and transaction fees shall be borne by the participant.

5. Confirmation of Registration

- A confirmation email will be issued upon successful receipt of payment.
- The confirmation email serves as official proof of registration.

6. Cancellation & Refund Policy

- No refund for cancellation received after registration confirmation or for none-attendance (no shows).
- All cancellation requests must be submitted in writing to the MARGMA, and subject to MARGMA approval.

7. Delegate Substitution

- Delegate substitutions are permitted with prior written notification to the MARGMA
- Substituted delegates must be from the same organisation, subject to MARGMA approval.

8. Programme Changes

- MARGMA reserves the right to amend the conference programme, speakers, topics, venue, or schedule without prior notice
- Such changes shall not constitute grounds for a refund.

9. Event Postponement or Cancellation

- In the event of postponement, rescheduling, or cancellation due to force majeure or circumstances beyond the Organiser's reasonable control, MARGMA reserves the right to retain the registration fee as credit for a future event or issue a refund at its discretion.
- MARGMA shall not be liable for any travel, accommodation, or related costs incurred by participants.

10. Liability & Insurance

- Participants attend the conference at their own risk.
- The Organiser shall not be liable for any personal injury, loss, or damage to property during the event.
- Participants are strongly advised to arrange their own travel and health insurance.

11. Personal Data Protection

- Personal data collected will be used solely for event administration, communication, and operational purposes.
- MARGMA complies with the Personal Data Protection Act 2010 (PDPA) of Malaysia.

12. Photography & Recording

- The Organiser reserves the right to photograph, audio record, or video record the conference.
- Such materials may be used for marketing, publicity, or reporting purposes without compensation.

13. Governing Law

- These Terms & Conditions shall be governed by and construed in accordance with the laws of Malaysia.
